**VOTING RESULTS AT ANNUAL GENERAL MEETING  
HELD ON 19 MAY 2020**

At the annual general meeting (“AGM”) of Haitian International Holdings Limited (the “**Company**”) held on 19 May 2020, a poll was demanded by the chairman of the AGM for voting on all the proposed resolutions as set out in the Notice of AGM dated 16 April 2020.

As at the date of AGM, the total number of issued shares in the Company was 1,596,000,000 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There is no restriction on any shareholders casting votes on any of the resolution at the AGM.

No shareholder of the Company was required to abstain from voting on any of the resolutions at the AGM nor any person has indicated in the circular of the Company dated 16 April 2020 that he or she or it intends to abstain from voting on or voting against any of the resolutions at the AGM.

The Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results in respect of the resolutions proposed at the AGM were as follows:
